When your request for an order requires a special such as a lift gate, a convention, military, residential delivery, inside delivery or any other accessorial charge, **we will consider that order as authorization in itself, and we will not request additional authorization.**

- Any shipment that the shipper declares a value, on the bill, to party will be charged \$.65 per \$100 declared.
- First 10 minutes are included in the delivery and pick-up of LTL freight (30 minutes at a convention center). After 10 minutes, FASTRUCKING will charge the bill to party \$15.00 per 15 minute interval. The bill to party will be notified of any delays before the free time expires.
- Dim weight factored at 194, applies to all shipments.
- Accessorial charges are subject to change without notice.
